

# **Aurora State Airport (UAO) History**

- Airport was established & managed by United States Bureau of Public Roads
- Transferred airport to State of Oregon's Highway Division
- State of Oregon's Highway Division transferred ownership to Aeronautics Division
- First Airport Master Plan was completed
- Parallel Taxiway, Rotating Beacon, Runway Reconstruction, Drainage, Lighting, and Apron Projects
- Property Acquisition (22 Acres)
- Property Acquisition (10 Acres, including tiedown apron)
- Airport Master Plan
- Runway Extension Project (from 4,104' to 5,004')
- Runway Reconstruction Project
- Parallel Taxiway Shift Project
- Airport Master Plan
- Air Traffic Control Tower Constructed
- Runway Justification Study







# FAA Airport Master Plan Overview

# FAA Airport Master Plans have a 20-year planning horizon that is divided into three periods:

- Short-term (0-5 years)
- Intermediate-term (6-10 years)
- Long-term (11-20 years)

### FAA has review and approval authority of the following work products:

- Aviation Forecasts
- Runway Object Free Area Modification of Standards Analysis
- Runway Protection Zone Analysis
- Airport Layout Plan

### Aurora Airport Property – ODAV Owned






## Land Use Summary

The Airport and its adjacent off-airport (known as through-the-fence) development are in unincorporated Marion County. All land use actions require Marion County approval.

The Airport and through-the-fence areas are zoned **Public (blue)**

- Agriculture/Residential (yellow)
- Residential (beige/tan)


