## Dear ODAV,

Please accept this this message as my PAC member input on the current Aurora master plan. First, I want to thank you for the great job "herding the cats" by getting input from users and affected individuals as well as organizing this project.

My strongest advice is to remove any consideration of condemning and destroying hangars, I believe these hangars are the lifeblood of the Aurora Airport and are necessary to the lives saved, forest fires fought, and many good careers created by the owner/tenants of these hangars. The method to protect those hangars is to eliminate the parallel taxiway and vehicle lane plans, neither of which are absolutely necessary and both of which can be accomplished to a degree by ODAV's purchase of the mid-field property south of the control tower that has been offered to ODAV on the 16th of this Month.

This one change will eliminate a huge amount of money being wasted, will improve safety by separating aircraft and vehicles and will protect hundreds of excellent Aviation jobs as well as protecting the 100% Aviation use of this property.

The second most important recommendation I make is to please closely consider and utilize the excellent information provided today and earlier to ODAV by the highly experienced Aviation architect and engineer Aron Faegre, reviewing this information, i see that it is straight from the FAA's own guidance. As this information was donated by airport users and airport business, it represents the best in public/private coordination, collaboration, and offers real opportunity for ODAV to create the best possible plan and save money doing so.
